## PROFILES



### DR JOSÉ IBRAIMO ABUDO

**Dr** Abudo is a Mozambican politician who served for a time as Minister of Justice, a position created in 1994 with the first multi-party elections in Mozambican history. He is a member of FRELIMO and a graduate of the University of Lisbon, where he received a master's degree in corporate law. He also served as Justice at the Administrative Court of Mozambique for 10 years, before been elected as Ombudsman from 2012 to 2018.

### **HONOURABLE ISAQUE CHANDE**

Honourable Chande is the Current Ombudsman of Mozambique (Provedor de Justica). He was the Minister of Justice, Constitutional and Religious Affairs from 2016 to 2018, before being elected as Ombudsman in 2018. He is a Member of the National Electricity Council (CNELEC) and a Law Lecturer at Eduardo Mondlane University.





### HONOURABLE CARLOS ALBERTO FERREIRA PINTO

Honourable Pinto is the second Ombudsman of the Republic of Angola. He was elected by the National Assembly (Parliament) in 2017 and took up office as the Ombudsman in 2018. He holds an LLB Degree from the Law Faculty of the University of Agostinho Neto, Luanda. He was a Member of Parliament to the National Assembly from 2008 to 2017 where he chaired the Commission for Constitutional and Legal Affairs from 2008 to 2012 and was appointed as the Vice – President of the Constitutional Commission that drafted the Constitution of the Republic of Angola in 2010.

#### HONOURABLE SULAYMAN ALSHANTI

Honourable Alshanti is the President of the Administrative Control Authority in the State of Libya. He was appointed to the position of Regional Coordinator for North Africa in 2018 during the sixth meeting of the AOMA General Assembly held in Rwanda. He was appointed to the position of Second Vice President of the AOMA during the committee meeting Association Executive in Abuja, Nigeria in 2019. Honourable Alshanti has extensive experience in the oversight work from (46) years of experience in this field, during which he held many positions within the authority. These include serving as Authority's Deputy in 2017, assuming the director of the General Department for the Supervision of Ministries in 2016, as well as



being the Director of the Department of Evaluation of Performance Rates in 2009. He also chaired many oversight committees within the Authority.



### **MR MOHSEN AWAD**

Mr Awad is a Member of the National Council for Human Rights (NCHR) and a member of the Board of Trustees, and the Arab Organization for Human Rights (AOHR). He holds a BSc in political science from the faculty of Economics and Political Sciences - Cairo University and a MA in African studies from the same university. Awards worked as a Researcher with special focus on African and the Arab affairs at the Egyptian Presidency in1964 until 1980.

a freelancer in1980, a Director of the Arab Future Publishing House in 1985, as well as a Director of the Arab Unity Studies Centre branch in Egypt from 1989 until 1992. He lectured at the Arab Research Institute - Arab League of States from 2002 until 2014 and worked as a Senior Researcher of the Arab Organization for Human Rights (AOHR) between 1983 and 1987, an Assistant Secretary General between 1987 and 2004 and a Board member from 2004 until 2008. He is former Secretary General between 2008 and 2011, as well as the Vice Chairman for the Arab Institute for Human Rights (AIHR – Tunisia).
