# Human Rights and Transition: The Ombudsmen and their contribution to the future

December 2, 3 and 4, 2021

# **1.** Presentation and Objectives

The annual Assembly is the activity foreseen in the ILO statutes for the purposes of reporting on activities, electing authorities and dealing with issues of interest to members. For more than a decade, ILO has made its assembly coincide with a seminar with the objectives of: *jointly analyzing issues related to human rights that are of interest to its members and that contribute to their specific tasks; generate an encounter space that enriches partners through the exchange of knowledge and information on the realities and specific responses of each country and region; promote the debate on human rights in general and the Ombudsmen Institutions in particular, with a vocation to reach multiple actors in order to spread and promote the culture of defense and promotion of human rights among citizens in general, civil society, the academy, the public sector and the media.* 

This seminar is the second to be held virtually and within the framework of the Covid 19 pandemic, which in the whole world has been going on for about two years. Although the situation has changed compared to 2020, in particular due to the existence of vaccines, it remains worrying for multiple reasons. The first is the enormous inequality in access to them, with countries in the North having vaccinated most of their population with two or three doses, while countries with fewer resources barely exceed 1%. Likewise, the emergence of new strains represents a growing threat, and again, with greater risk in countries with fewer resources. To this, it is added that 2021 is highlighting the social and economic consequences of the pandemic and its management, with global indicators showing deterioration in most indicators of well-being, increasing the already extreme inequality, particularly in Latin America and the Caribbean. This panorama has led ILO to hold its annual meeting virtually, and to continue analysing not only the pandemic but the historical moment and the projection of the future from a Human Rights perspective and in particular the role that the Ombudsmen can play in this scenario.

The virtual modality allows us to consider other objectives: to reach as many members and other people/institutions active in the promotion of human rights as possible, in order to consolidate the contributions of the various regions and their particularities through their

full integration into the regular operating mechanisms of ILO; to know the various responses to the pandemic in the various countries, to put them in dialogue, and to advance in a framework of institutional strengthening that allows the ombudsmen's offices to give the best responses to situations of exception and the possible violations of Human Rights that result from them; to systematize the learning in order to give a clear and forceful message regarding the principle of non-regression of human rights and analyse the role of the Ombudsmen's offices in this regard.

The Assembly and the Seminar are named Berta Caceres, a Lenca indigenous woman from Honduras, a human rights defender, murdered in March 2016 in her home for her permanent struggle for the rights of the Lenca people, the protection of the territory and the natural environment. We chose to come together remembering Berta Caceres in a historical moment where the defence of Human Rights necessarily implies a defence of Life in its diversity, and because the daily reality of our continent, where there is the highest number of murders of environmental defenders around the world, reminds us of the centrality of that struggle in order to imagine a truly just, equitable and sustainable future.

In this sense, the focus of the meeting, based on the learnings of the responses to the pandemic, is to collectively think about the transition and do it from a perspective of rights anchored in the protection of our natural environment.

#### Methodology:

The seminar will be structured based on the following format:

- Opening conference
- Presentations that give an account of regional experiences
- Dialogue tables, where central topics of the seminar will be debated by several participants, encouraged by a moderator.
- Participation of the public through the platform, in written or verbal form.
- Artistic expressions.
- The seminar will be recorded in order to disseminate its contents.

#### 1. Just transition

- Human Rights and the Defence of Life in its Diversity
- Climate Change and Human Rights
- Right to the city in the transition to the post-pandemic

# 2. Digital transformation and infringement of rights

- Open government and digital transformation processes.
- Freedom of expression and "infoxication"

- Surveillance capitalism what role is there for the Ombudsmen's offices?

# 3. Collective rights and solidarity
