FROM THE PRESIDENT'S DESK

Since your Board's decision made at the annual meeting in Hong Kong to accept the application of the Austrian Ombudsman Board and recommend relocation of the I.O.I. administrative offices from Edmonton, Alberta, Canada to Vienna, Austria, we have been progressing toward achieving that end. In preparation for the bylaw changes that must be adopted and ratified by the General Assembly at our June World Conference in Stockholm, I have asked several members of the Board to serve as a Transition Committee. I have also sought the advice and services of David Tang, a Canadian attorney who is one of Canada's leading experts in the field of nonprofit corporation law, to draft those bylaw changes and advise us in the decisions we make. I.O.I. Treasurer Dean David Percy has consulted with officials at the University of Alberta, and many of the important holdings of the I.O.I.'s ombudsman library will be integrated into the University's library system. When accomplished, that collection will become available to researchers and practitioners globally through interlibrary loan.

The field of ombudsman research is progressing on several fronts. I am informed by our Institute Administrator, Diane Callan, she and our Editor, Linda Reif, are in the final stages of editing the *International Ombudsman Yearbook* under our current contract. We look forward to the publication and distribution of this valuable resource in the near future. Diane, World Conference host Mats Melin, and Ontario Ombudsman André Marin are cooperating toward realizing publication of the papers presented at the Stockholm World Conference and the Bicentennial Celebration of the Swedish Ombudsman Office as a separate publication.

Of significant importance to our global ombudsman community is the reemergence of ombudsman writing independent of the publishing program of the I.O.I. In Europe we have seen the recent publication of scientific scholarship of an empirical and theoretical significance by Gabriele Kucsko-Stadlmayer. The edited book is entitled *European Ombudsman-Institutions*, and was published in 2008 by Springer Wien New York. On the practical side of our work, Gareth Jones, Director of the Ontario Ombudsman's Special Ombudsman Response Team, will have his book, *Conducting Administrative, Oversight and Ombudsman Investigations*, published by Canada Law Book in April. I have read Professor Kucsko-Stadlmayer's book and reviewed a pre-publication version of Gareth's. Both are destined to become essential contributions to the understanding and achievement of ombudsman work.

In December I traveled to Taiwan at the invitation of Chien-shien Wang and Louis Chao of Taiwan's *Control Yuan*. I spent several days in Taipei and Kaohsiung exchanging ideas and learning about the operation of the *Control Yuan*, one of the five constitutional organs of the government of Taiwan.

Secretary Alice Tai and Administrator Diane Callan have been working hard to process the membership applications and renewals that have been coming in anticipation of the Ombudsman World Conference. If you have not already done so, I urge members to complete the conference attendance form, and I look forward to be with you again in Stockholm.

THE FOURTH MANDATE OF THE CONTROL YUAN STARTED OPERATIONS ON AUGUST 1, 2008 AFTER A THREE AND A HALF YEAR VACANCY

The *Control Yuan*, the highest supervision organ of the Republic of China (Taiwan), started operations on August 1, 2008 after

having been dormant since February 1, 2005. According to the Constitution, the *Control Yuan* shall have 29 members, including a President and a Vice President, all of whom shall serve a term of six years.

The members of the Fourth Control Yuan were nominated by the President of the ROC (Taiwan) and were approved by the Legislative Power. The inauguration ceremony was held on August 1, 2008. The newly elected President of the Control Yuan, Chien-shien Wang, former Minister of the Ministry of Finance, is an expert in accounting and financial policies. The Vice President, Jinn-lih Chen, has a Ph.D. in agriculture. Dr. Louis R. Chao, member of the Control Yuan and Chairman of International Affairs Committee, was nominated again. The other 26 members have specialties in the areas of judicial, educational, medical and human rights matters. The expiration of the Fourth Control Yuan will be on July 30, 2014.

ANOTHER FAILURE OF THE KOSOVO ASSEMBLY TO APPOINT A HUMAN RIGHTS OMBUDSPERSON

On February 12, 2009, the Kosovo Assembly failed again in the process to appoint a Human Rights Ombudsperson for Kosovo. The Kosovo Assembly has been given the responsibility for the appointment of an Ombudsperson since January 2006. There has been an Acting Ombudsperson for over three years. Kosovo declared independence in early 2008.

The Kosovo Ombudsperson is empowered to investigate alleged human rights violations and abuses of authority by public institutions. In addition to investigations, it issues reports and provides legal services and public advocacy. The initial structure of the Kosovo Ombudsperson was established under the auspices of the UN mission in Kosovo in 2000 with the Ombudsperson being an international appointee of the Special Representative of the UN Secretary General.

SECOND MEETING OF THE NETWORK OF MEDIATORS AND OMBUDSMAN OF THE MEDITERRANEAN AREA AND ESTABLISHMENT OF THE MEDITERRANEAN OMBUDSMAN ASSOCIATION

The second meeting of the Network of Mediators and Ombudsman of the Mediterranean Area took place in Marseille, France from December 18 to 19, 2008. The main theme of the meeting was "Ombudsman of the Mediterranean Area—Challenges in a Common Space". Ombudsman and mediators from twenty-three states of the Mediterranean area and representatives of five international and regional organizations dealing with human rights attended this meeting (the IOF, the European Ombudsman, the Arab League, the Council of Europe and the UNHCHR).

The meeting led to the implementation of a new ombudsman association: the Mediterranean Ombudsman Association, located in Morocco at the office of the Morocco Ombudsman (*Diwan Al Madhalim*). The Ombudsman of Morocco was elected as the President of the new Association. The Vice-Presidents are the *Defensor del Pueblo* of Spain and the Ombudsman of Egypt, and

the *Médiateur de la Republique* is the Executive Secretary. The Ombudsmen of Tunisia, Palestinian Territories, Israel, Greece and Croatia were elected as Board directors. The IOF, European Ombudsman, Arab League, Council of Europe and UNHCHR will serve as consultative Board members.

The next meeting of the Mediterranean Ombudsman Association will be held later in 2009 in Athens, Greece.

OFFICE OF REGIONAL OMBUDSMAN OF FRIULI-VENEZIA GIULIA IN ITALY ABOLISHED

On August 1, 2008, the Regional Council of Friuli-Venezia Giulia voted to abolish the Office of the Regional Ombudsman (*Il Defensore*) of Friuli-Venezia Giulia. The decision was published on August 22 and entered into force on August 23, 2009.

OMBUDSMAN OF PAKISTAN CREATES CHILDREN'S COMPLAINT OFFICE INSIDE OMBUDSMAN INSTITUTION

The Ombudsman (Wafaqi Mohtasib) of Pakistan, Mr. Javed Sadiq Malik, in partnership with UNICEF, has created a Children's Complaint Office inside the Ombudsman Secretariat. This is the first child ombudsman service in Asia. The Children's Complaint Office has been established under the Responsible, Enabling and Accountable Mechanisms for Child Rights (REACH) project. The Children's Complaint Office is dedicated to receiving and resolving complaints from and about children against maladministration in any federal agency (e.g. health, education, social welfare ministries,

immunization, HIV/AIDS and tobacco use and control programs) and will help Pakistan to implement its obligations under the UN Convention on the Rights of the Child. Complaints can also be made online and by email. Over time, the coverage of this service will be extended to the eight regional offices of the *Wafaqi Mohtasib*.

The REACH program also will engage in consultations with stakeholders, including children, through mechanisms such as youth parliaments and civil society children's rights projects. Under the program the Ombudsman will conduct research on systemic problems in administration that lead to children's rights violations.

Mr. Malik states that "children constitute nearly half of Pakistan's population but had not yet been provided any forum for grievance redress. By setting up a dedicated children's complaint office, we are lending voice to a hitherto silent and marginalized segment of our society and supplementing ongoing efforts to respecting and protection of children's rights."

In addition, as part of the REACH project a proposal has been made to establish an Asian Coalition for Child Rights and Development (ACCORD) through which Asian Ombudsman Association member countries will be encouraged to establish children's ombudsman offices either by extending their current arrangements (as in Pakistan) or by setting up independent children's ombudsman institutions.

UZBEKISTAN HUMAN RIGHTS OMBUDSMAN 2008 REPORT

On February 12, 2009, the Legislative Chamber (Lower House) of the *Oliy Majlis* of the Republic of Uzbekistan held a session. The Authorized Person for Human Rights (Ombudsman) of the *Oliy Majlis* of the Republic of Uzbekistan, Sayyora Rashidova, spoke on the outcomes of activity in 2008, according to the report.

Last year the parliamentary Ombudsman actively participated in implementing state policy on ensuring constitutional rights and freedoms of citizens, and improving the national legislation in this sphere in line with universally recognized standards. Also, the Ombudsman has constantly learned about and scrutinized both oral and written addresses of citizens, monitored research and engaged in broad awareness work among the population. The adoption of the Decree of the President of the Republic of Uzbekistan "On the Action program dedicated to the 60th anniversary of the Universal Declaration of Human Rights" served as a powerful impetus in terms of protecting human rights and freedoms in Following the report, lawmakers 2008. engaged in floor debates on the basic elements of the Ombudsman's work in 2008. They stated that starting from the early years of its sovereign development Uzbekistan has paid profound attention to protecting human rights and freedoms. The nation's commitments to human rights have been declared in the Constitution, as well as in other legislative documents. Over the years of independence, Uzbekistan has joined more than 60 basic human rights documents and six fundamental treaties adopted by the United Nations in this sphere.

After tight scrutiny and floor debates, the Uzbek legislators approved the 2008 report of the activity of the Authorized Person for Human Rights and adopted the related resolution.

TAJIKISTAN EXPECTED TO ESTABLISH A HUMAN RIGHTS OMBUDSMAN INSTITUTION IN 2009

It is reported that Tajikistan is expected to establish a human rights ombudsman institution in 2009. This development was discussed at a conference held in December 2008 on "Tajikistan and the 60th Anniversary of the Universal Declaration of Human Rights", co-organized by the OSCE, UNDP, the Office of the UN High Commissioner for Human Rights, the Tajik government and the Swedish government.

APPOINTMENTS/RETIREMENTS/ANNIVERSARIES/AWARDS, ETC.

HONG KONG

The Chief Executive has appointed Mr. Alan Lai Nin as the new Ombudsman of Hong Kong for a five-year term commencing April 1, 2009. Mr. Lai joined the Hong Kong government in 1974, serving initially as a Judicial Clerk and later as an Executive Officer. He joined the Administrative Service in 1976. He has worked in various bureaux and departments, including the Home Affairs Department and the former Office of Unofficial Members of the Executive and Legislative Councils. He was the Director-General of Trade from 1996 to 1999 and Commissioner, Independent Commission Against Corruption, from 1999 to 2002. He was the Permanent Secretary for Financial Services and the Treasury from 2002 to 2007.

He replaces Ms. Alice Tai whose term of office expires on March 31, 2009 after completion of her second term as Ombudsman. Ms. Tai has also served as Secretary of the I.O.I. for a number of years and as Secretary of the Asian Ombudsman Association. The Chief Executive of Hong Kong paid tribute to Ms. Tai, stating, "Ms. Tai has demonstrated able leadership and strong commitment to the work of the Office of the Ombudsman in the last 10 years. During her term of office, the Ombudsman has proved to be a valuable and effective means of redress for citizens' complaints. Her contribution in handling public complaints maladministration and improving the quality of public administration is widely recognised by the community."

IRAN

Mr. Mostafa Pour Mohammadi has been appointed as the new Head of the General Inspection Organization of Iran. He replaces Mr. Mohammad Niazi who has retired.

THAILAND

On October 13, 2008, Mrs. Panit Nitithanprapas was appointed by the King of Thailand as an Ombudsman of Thailand for a six-year term. She replaced Mr. Poonsup Piya-Anant whose term had expired. Prior to her appointment, Mrs. Nitithanprapas worked as an Assistant Permanent Secretary and Inspector General of the Office of the Permanent Secretary, Secretary-General of the Office of the Commission for the Management of Land Traffic (OCMLT) and Permanent Secretary, Office of the Permanent Secretary, Ministry of Social Development and Human Security.

Thailand has three Ombudsmen, currently: Chief Ombudsman General Teeradej Meepien (Ret.), Mr. Pramote Chotimongkol and Mrs. Nitithanprapas.
