# **SPEAKER & FACILITATOR PROFILES**



Honourable Edouard Nduwimana is the second Ombudsman of the Republic of Burundi. He is a career Magistrate who has occupied various positions. As Prosecutor of the Republic, and later Governor of the province in 2008, he invested in the mobilization of the population for development of his province. He was Home Affairs Minister from 2009 to 2015 and was decorated by the President of the Republic in 2014 in recognition of the administrative performance and legal reform he initiated. He was elected Member of Burundian Parliament in 2015 and later elected second Deputy President to the Office of the National Assembly, before being elected Ombudsman of the Republic on 22 November 2016 when he was sworn in before the Burundi Head of State and the two chambers of the Burundian Parliament. Hon. Nduwimana is the current Treasurer of AOMA and a Board Member of AORC.

Honourable Dr Endale Haile is the current Ombudsman of Ethiopia who was appointed in July 2019. Previously, he was the Vice President for Administrative and Student affairs in Debre Berhan University (2018), Dean of Students (From 2015 to 2018), and Assistant Professor (2010). He was also a member of parliament from 2005 to 2010. His short-term training includes: BPR, Public Policies and strategies, The role of legislative in law and budget making process, Project management, finance and rural development, Research methodology. His membership of professional Bodies and various committees are namely, Ethiopian Management Professional Associations, Director for student's services supportive work process, Chairperson for purchasing approval committee and, Chairperson of discipline committee in DBU. MBA lecturer in Strategic management, Project management and planning, Public Project management, Human Resources management, Research Methodology, and Leadership and Change Management.





**Honourable Antonia Florbela de Jesus Rocha Araújo** is the current Ombudsman of the Republic of Angola, elected by the National Assembly on May 2021. She is also currently a Member of the Board of the International Ombudsman Institute (IOI); holds a Master's degree in International Law (Classic University of Lisbon) and a Law Degree by the University Agostinho Neto in Luanda – Angola. She received training on Human Rights in Angola, Portugal and the United Kingdom of Great Britain. She has participated in several work groups on projects for the elaboration of legislation, has experience in the field of International Relations, was a lecturer at the Law school of the Catholic and Lusíada Universities in Angola, and at the Faculty of Letters and Social Sciences of the Agostinho Neto University. She was also Secretary for Judicial and Legal Affairs of the President of the Republic and Deputy Ombudsman of the Republic of Angola.

Honourable Advocate Basilius Maketo Dyakugha is the current Ombudsman of Namibia from October 2021. He is a former Regional Councilor and holds Baccalaureus Juris (B. JURIS) and Bachelor of Laws (LLB) degrees from the University of Namibia. He is admitted Legal Practitioner of the High Court and Supreme Court of Namibia. He was a private Legal Practitioner/Attorney, working at a local law firm in Windhoek. He joined the Ministry of Justice as a Principal Legal Officer in 2007. He was the Head of Human Rights and Humanitarian Law Division, at the Ministry of Justice. He was responsible for drafting State reports to the UN Treaty bodies, The African Commission on Human and Peoples' Rights, and Universal Periodic Review (UPR) to the Human Rights Council for 13 years. He was a member of Namibia's team to the Human Rights Council from 2014 until 2016 in Geneva, Switzerland. He also served in



various capacities including as a member and secretary of the Disciplinary Committee of Legal Practitioners (Law society of Namibia), and a member of the labour Advisory Council. He was the Head of the Directorate, Law Reform in the Ministry of Justice and Secretary to Law Reform and Development Commission of Namibia for 3 years.
