

About the workshop

The Catalan Ombudsman, president of the European Chapter of the International Ombudsman Institute (IOI), organizes, within the frame of the IOI, an International Workshop, to be held in April 2016, on the contemporary challenges and threats that human rights are facing, and the task of Ombudsman institutions therewith.

Lately, security concerns have grown in Europe and the rest of the world, putting at risk fundamental human rights such as freedom of expression and privacy. Likewise, the refugee crisis, which adds to the continuing migratory movements, not only is a challenge for Europe's solidarity, but it also risks fuelling the ghost of racism and xenophobia in the continent.

All of this is taking place in the midst of a deep economic and financial crisis that represents a threat to social rights and puts large sectors of our societies at risk. Public policies at state and international levels need to address these phenomena with generosity and full respect of human rights, and the Ombudsman offices need to be particularly attentive to legislation and administrative practices that infringe rights.

At the same time, Ombudsman institutions themselves are in the midst of the debate on the guarantees for human rights. On the one hand, many of them are acquiring new functions and competences, in areas as diverse as the prevention of torture, alternative dispute resolution, transparency and access to information or LGBTI rights, among others. On the other, though, many of these institutions are threatened by attacks to their independence, lack of resources or their disappearance.
